HOLD HARMLESS AND INDEMNIFICATION AGREEMENT

The person/organization (licensee) submitting this application hereby assumes the entire responsibility and liability for any and all damages and/or injuries of any kind or nature whatsoever, to all persons, whether employees or otherwise and to property growing out of or resulting from the rental of buildings or any other property owned by the Board of Education of the Village of Ridgewood and for any and all damages and/or injuries of any kind which shall occur in connection therewith and Licensee agrees to indemnify, defend and hold harmless the Board, their agents, servants and employees from and against any and all losses, expenses including legal fees and disbursements, damages or injuries occurring in connection with, or resulting from the use by Licensee, its agents, or employees, of any building or other property rented from the aforesaid Board arising under any law whatsoever, which may be in effect in the locality in which the work is situated or otherwise.

The licensee also assumes the entire responsibility and liability for damages and injuries of any kind or nature whatsoever, to all persons, whether employees or otherwise and to property arising out of or resulting from licensee's operation, activities, or omissions and for any and all damages and injuries of any kind which shall occur in connection therewith.

The licensee agrees to indemnify, defend and hold harmless the Board, its agents, expenses, loss or liability whatsoever arising out of or in connection with the operation, activities or omissions of the licensee, its employees and/or servants or agents in rental of the buildings or any other property owned by the Board of Education of the Village of Ridgewood, including, by way of example and not by way of limitation, any losses, expenses, including legal fees and disbursements, damages or injuries occurring in connection with, or resulting from the use by the licensee its servants, agents and/or employees, of any equipment, stock, appliances, implements, tools or machinery or any other property owned, rented borrowed by or assigned to the Board; provided, however, that the licensee's obligation to indemnify the Board shall not apply to damage or injury resulting solely from the negligence of the Board, its employees, servants and/or agents.
